Establishing Heavenly Government on Earth

- Zech 3:7 “Thus says the Lord of hosts, ‘If you will walk in My ways and if you will perform My service, then you will **also govern My house** and also **have charge of My courts**, and I will grant you free access among these who are standing here.
- To govern or rule the house we need laws and legislation
- We have charge of courts and access to councils to get legislation

Establishing Heavenly Government on Earth

- What is legislation?
- The process of making or enacting laws
- What is it to legislate?
- To use authority to provide, create, prepare or rule
- What authority do you have?

Establishing Heavenly Government on Earth

- To legislate you need a sphere of authority your area of jurisdiction
- To have a sphere of authority you need a mandate
- To legislate that mandate you need a blueprint (plan or vision)
- Laws give you the specific authorisations needed to manifest the blueprint

Establishing Heavenly Government on Earth

- The basis of all laws and legislation is love, the precepts of God His nature and character
- Statutes of God – How God sees things ordered
- Laws of God the decrees that bring order
- Ordinances of God the directions or strategies for manifestation

Establishing Heavenly Government on Earth

- I learned about legislation from Wisdom who took me to the Court of Kings
- I was sat at a bench with a scroll in front of me – no clue
- From my spirit the Law of Fatherhood and sonship was written on the scroll to my surprise

Establishing Heavenly Government on Earth

- Wisdom then took me to the Court of Chancellors
- I presented the scroll and the 4 Chancellors sealed the scroll with Lion Ox Eagle and Man seals and gave it back to me

Establishing Heavenly Government on Earth

- Wisdom then took me to the Court of Scribes I presented the sealed scroll and they recorded it into the statutes or records and gave it me back
- I was now authorised to use this law
- For corporate use we agreed a law as a Bench of 3 and ratified it with our Bench of 12

Establishing Heavenly Government on Earth

- The laws of a nation or the bye laws of a county or city are recorded in their statute book
- A statute is a formal written enactment of a legislative authority that governs a city, state, or country. Typically, statutes command or prohibit something, or declare policy.

Establishing Heavenly Government on Earth

- The laws on the statute books are what can be used to legislate with
- Earthly or religious laws are often seen as prohibitive
- Heavenly laws are mainly permissive they authorise us to act in alignment with God's kingdom and His will

Establishing Heavenly Government on Earth

- What do you do with a law?
- Use the authority it gives you
- Take it to the Court of Angels for assignments
- Take it to the Court of War/Strategy for further heavenly or earthly strategies
- Administrate it from your thrones to decree, declare, call forth etc.

Establishing Heavenly Government on Earth

- How to shape laws and legislation
- As sons of God we are called to rule and reign in life.
- This then requires us to operate governmentally as Kings and to take charge (responsibility) for the earthly outworking of the Kingdom of God in our spheres of authority.

Establishing Heavenly Government on Earth

- As sons we are now learning how to form and shape the laws that will provide structure and authority to our realms of dominion enabling us to establish heavenly government.
- God is revealing laws to us and teaching us how to legislate from Heaven to Earth

Establishing Heavenly Government on Earth

- However, often when we begin to get “laws” from God corporately we do not always get a nice and tidy, neatly arranged download.
- Rather we get statements, declarations, scriptures and impressions etc.
- These need to be shaped into something that is legislative and understandable

Establishing Heavenly Government on Earth

- Often different people will get different facets of the same law but will not recognise it is related until everything is collated and structured.
- So, to help with this process the following structure is helpful in bringing shape to the legislative process.

Establishing Heavenly Government on Earth

- Framework strategy worked out in practice to help formulate laws
- Context of the law
- Authority, rights and powers the law gives
- Jurisdiction of the law
- Consequences and results

Establishing Heavenly Government on Earth

- Context
- This should form a clear explanation of what the law is for.
- This is the background to the law being written and can contain all of the supporting information relevant to the law being drawn up.

Establishing Heavenly Government on Earth

- The following are examples of what could be included:
- Scriptural references
- Information from a blueprint
- Other reasons the law is needed that God has revealed or you have seen in the heavenly places

Establishing Heavenly Government on Earth

- Authority, Rights & Powers
- In essence, this is what the law enables you to do.
- Often with statements like:
 - You are authorised to
 - You are empowered to
 - You have the right to

Establishing Heavenly Government on Earth

- Authority – this is where God gives specific explanation of what you are being authorised to do.
- It is the express permission to use the law.
- There may be many different and varied things authorised

Establishing Heavenly Government on Earth

- Rights – these are the privileges and entitlements God has given to operate the law.
- Rights come from your identity and position
- Individual rights or corporate rights when part of a Bench

Establishing Heavenly Government on Earth

- This could include:
- The right to make declarations or proclamations,
- The right to be acknowledged in Heaven and on Earth as having this authority
- The right to enforce the law and hold others accountable

Establishing Heavenly Government on Earth

- Powers – These will be governmental in nature.
- You may have authority but you also need the power to use it
- You may have a court order or a verdict but you have to have the ability to use those things

Establishing Heavenly Government on Earth

- This may include:
- Abilities, (healing, manipulation of matter, etc.)
- Functions, (Judicial, priestly, kingly etc.)
- Skills and competences (aptitudes, know-how, expertise, etc.)
- Faculties (senses, gifts, capabilities, etc.)

Establishing Heavenly Government on Earth

- Jurisdiction
- This equates to who and what the law applies to.
- All law applies to something. It has specific government over territories, realms, dimensions, people, places or things.

Establishing Heavenly Government on Earth

- The Laws God gives us are governmental and therefore give authority for dominion and the right to rule over a specific area of responsibility.
- This is not to control but to release blessing, freedom, harmony, health etc. to find and fulfil destiny.

Establishing Heavenly Government on Earth

- Just because you have a heart for something or compassion for someone does not mean you automatically have jurisdiction
- It is important we don't step outside our spheres of influence or specific mandates

Establishing Heavenly Government on Earth

- E.g. Devon, Cornwall, Somerset etc.
- Just because you live somewhere doesn't necessarily authorise you
- You have to carry something in your heart and be given the specific mandate

Establishing Heavenly Government on Earth

- This could be for:
- A people group – Christians in general, Ekklesia, mountain sphere, vulnerable group, etc.
- An earthly place or territory – Totnes, Barnstaple, Devon, England, Germany, UK, Europe, USA, the World, (Universe!)

Establishing Heavenly Government on Earth

- Spiritual places – a dimension of heaven, your mountains, church mountains, the enemy's trophy room, courtrooms
- Spiritual Beings – angels, angelic beings
- Resources – money, crops, water, power sources, etc.

Establishing Heavenly Government on Earth

- Consequences or results
- This is what happens when the law is used and what happens when the law is opposed or broken.
- Expectations that manifest blessing
- Contempt of court
- Ongoing use to maintain authority

Establishing Heavenly Government on Earth

- This will include the expected results, effects or outcomes such as:
 - What we do as a result
 - Making declarations, decrees, creative statements
 - Assigning angels, releasing sounds

Establishing Heavenly Government on Earth

- Discernment and judgments
- Justice, Blessings, Freedoms
- Favour, Peace
- Multiplications, Salvations
- Restorations, Miracles
- Much more...fill in the blanks!

Establishing Heavenly Government on Earth

- Also, it will detail any consequences of non-compliance such as:
- 7 fold return for everything stolen
- Return of curses spoken
- Removal of rights from those in opposition
- Loss of favour and blessing
- Authority to use the courts of Heaven to enforce the law

Establishing Heavenly Government on Earth

- Law of unintended consequences
- Be as prepared as possible for things that the law releases or causes
- Cause and effect
- Prepare resources
- Communicate with those it might affect

Legislative Groups

- God spoke to me about giving Him time to legislate (to make or enact laws)
- I had been using existing legislation to administer the kingdom
- Making new legislation using the authority it releases to see the rule of God's kingdom bring restoration

Establishing Heavenly Government on Earth

- Son legislate the area, region and nations for justice and call for freedom.
- I call you to administrate My heart for My people's freedom from religious oppression.
- That was my mandate

Establishing Heavenly Government on Earth

- What laws was I supposed to make?
- What areas of legislation?
- I engaged with Wisdom and sought revelation
- Wisdom took me to the Court of the Councils of the fathers – 24 Elders

Establishing Heavenly Government on Earth

- They gave me some specific assignments and general advise
- What was on my heart from engaging with the Father
- One specific mandate was to make the Law of religious freedom
- I went to the court of kings sat at the bench and called for a scroll

Establishing Heavenly Government on Earth

- Law of Religious Freedom
- I hereby authorise the law of religious freedom.
- This law approves the right of the Joshua generation to set My people free

Establishing Heavenly Government on Earth

- You are authorised to bring freedom to the oppressed to release light into the shrouded darkness of the old Moses order
- You are authorised to administer Emmaus road like encounters to those whose minds have been veiled by the coverings of men.

Establishing Heavenly Government on Earth

- You are authorised to call for and administrate justice for God's people.
- In love you are empowered to challenge the old wineskins and their associated mind-sets.
- The old Moses order mountains can be shaken with the winds of change.

Establishing Heavenly Government on Earth

- You are to call the Joshua Generation to action to cry into the valley of decision and release heaven's sound and light.
- You have been assigned the ordinances of the angelic hosts to engage in visitations, dreams and visions

Establishing Heavenly Government on Earth

- I took the scroll to the Chancellor's court it was agreed, authorised and sealed
- I took the sealed scroll to the Court of Scribes and it was written into the statutes
- I am empowered to use it to legislate

Establishing Heavenly Government on Earth

- On the basis of the law of religious freedom:
- I call for the veils to be removed from those covered by resistors and rejecters of the new heavenly order.
- I call for justice on the basis of God's judgement, the exposing of those refusing to take the people into the promised inheritance.

Establishing Heavenly Government on Earth

- I call for a stirring and quickening of the hearts of those who have been covered and limited.
- I call for a new generation to arise.
- I call for mercy and the light of truth to shine brighter and with more intensity into the darkness of the coverings of men.

Establishing Heavenly Government on Earth

- I call for justice and freedom from the religious evangelical spirit that is plaguing God's people.
- I call for a holy dissatisfaction to grow in the hearts of God's people and the cry to go out from deep within “there must be more than this”

Establishing Heavenly Government on Earth

- I call for the sound of heaven to resonate in the hearts of those who will become hungry for more as they become dissatisfied with junk food and baby food.
- I call for more angelic encounters, visitations dreams, visions and supernatural engagements.

Establishing Heavenly Government on Earth

- I call for new desire to rise in the hearts of those who have been misled and covered by religious veils of doctrine and theology that denies the supernatural as normal to our lives.

Establishing Heavenly Government on Earth

- I call for an open heaven environment
- I call for the revelation and releasing of heavenly mandates and blueprints
- I call for God's will and kingdom to be revealed and released
- I call for the government of heaven to be established on the earth as it is in heaven

Establishing Heavenly Government on Earth

- I call for the facilitation of heavenly perspectives
- I call for the release of heavenly, national, regional, area, local and personal mandates
- I call for all to be seated in their heavenly places of rest and authority.
- I call for God's kingdom to be manifested on earth as it is in heaven
